Wetland/Aquifer Maps and Wetland Law

- Michael brought up the question of whether we need to be consulting the aquifer map when looking at applications to the planning board. Tabling for future discussion.
- **Barbara** to add the Jurisdictional Wetlands map to the NRA maps in the LaserFiche under the NRI maps. Right now it's in a different folder and the file is named 12a even though the map itself isn't labeled 12a.
- Katherine mentioned the new wetland law and we noted the map numbers referenced in the law might not be accurate. She will follow up.

Library of Local:

- Carol Bancroft, the director of the Clinton Community Library, updated us about the Library of Local, a partnership between libraries, the Mid-Hudson Library System, and Partners for Climate Action Hudson Valley.
- Described kiosk that is in the library that has resources and a seed library. Looking to rebuild interest in the seeds in 2026
- They've hosted a number of environmentally themed workshops and have two nature backpacks that can be checked out.
- The library did a water display and flyer related to our water talk last month to help promote it.
- Offered any help to the CAC in the future - look for programs where we could collaborate
- Barbara asked if we could do an invasive species event in the spring
- Library has more success with adult programs than kids; integrating into story time is the way to reach kids.
- We could add the Library of Local logo to our events and post relevant library events on the CAC website.
